IV. Chair's Report

a. Budget Training November 5th

Budget training for upcoming budget season. There have been changes.

c. Gender Neutral Bathroom

- i. Survey Question
 - We should include where the money funding this is coming from. Word it in a way that says it does not increase our student fee.
 - Need to make sure our survey does not sound biased.
 - <u>Maybe make an awareness article</u> "are you aware that..."
 - we won't get much feedback from it though, so a questionnaire is better.
 - *Process* = awareness article, questionnaire, then survey
 - ** Motion to conduct a survey (review) for how to implement a GI bathroom funded by SOR —Ben, Call to question Marco, Acclimation Danielle, approved.

- we are going to stall the survey and let the LGBT groups on campus take over the awareness part. UMC Board agreed to request SOR funding for a feasibility study to be conducted first in order to see wherein the UMC a multi-stalled GNR could be placed and how much it could potentially cost.

ii. Scarlet Bowen Director LGBTQ Resource Center

- Sharing with us research and resources. Since 2008, we have protections for LGBT individuals provided by Colorado law. According to one law, we can use whichever bathroom we wish to use.
- Bathrooms have been a site for pretty heavy discrimination.

 Some discrimination against African Americans, Women (not having enough stalls), Handicapped, families (to be able to help children), and little people (sinks not a good height).
- Listened to different accounts from people
- Ace, co-leader of Transcend sharing transgender experience. How not having a gender neutral/gender-inclusive bathroom has been an obstacle. "What are you doing in here?" "Are you sure you're in the right bathroom?"; gets harassed with these questions.
- It's not just in the UMC that this harassment happens; it happens everywhere.
- Gender inclusive bathroom should be in a high-traffic location
- This is a basic need that should be provided for everyone.
- Would like to have an equal amount of space for the genderinclusive multi-stall restrooms as we have in our current bathrooms

Randy from the Center of Multi-cultural Affairs = Single parent with a 3 year-old daughter that would like a family bathroom with multi-stalls.

Research =

Gender Inclusive Bathrooms Benefit Women – <u>safety for women</u>. Women's bathrooms aren't locked and are accessible by anyone at this moment. There is no guarantee that they are safe. There is plenty of evidence that there has been sexual assault or harassment in these bathrooms. There is no evidence for this in GI bathrooms. There is <u>quicker access for women</u>; more stalls that are available.

Questions about gender safety -

- 1.) Someone could pull another person into the locked stall and no one could access that bathroom to intervene.
- 2.) Someone could fall and hurt themselves in the bathroom and they would be locked in there, unable to be helped.
- → building managers would be able to have access to these restrooms
- noticed there weren't any key access points on the doors in the C4C
- * Possible titles for the bathroom: "All-Access Bathroom", just "Bathroom" or "Restroom", "Universal Restroom", or "All Genders Bathroom"
- Possibly include information in the Freshmen Orientation pamphlet for bathrooms that could be used (the bathrooms wouldn't be finished for the next incoming freshmen).
